II. TECHNICAL SPECIFICATIONS

1. PURPOSE

The purpose of this request is to hire a company to do the replacement of ONE (1) water heater, expansion tank and mixing valve belonging to the Embassy of the Argentine Republic in the United States of America, located at 1600 New Hampshire Ave, N.W., Washington DC, in accordance with the technical specifications and other documents governing this request for proposals.

2. SCOPE OF WORK

The scope includes the supply of labor and all the necessary elements for the service to be complete and adequate for its purpose, in accordance with the trade's rules, the technical specifications and the documentation governing this invitation to bid. If the technical specifications or bidding documents do not list all the necessary work to achieve the result or the necessary elements to perform them, the Contractor must perform and/or provide them, without the right to demand any additional payment.

The work shall be complete, comply with the local rules and regulations in force, all necessary insurance and conform to the trade's rules according to the purpose for which it is to be performed.

3. TERM

The term for the execution of the works detailed in this contract is THIRTY (30) DAYS counted from the day after the Purchase Order is received.

4. VISIT

In order to accurately assess the characteristics of the installation, its difficulties and costs, the bidder must make a mandatory visit to the Embassy (Representation).

The Representation will facilitate all the visits requested by the interested parties, so that the Co-contractor may not later allege ignorance and/or lack of foresight in the conditions under which the contract will be executed.

The visit shall be made up to the date and time indicated on the cover page of the bidding documents, after coordination with the Representation, and the corresponding Certificate of Visit (APPENDIX B) shall be issued, which shall be submitted together with the bid.

5. FORMALITIES AND PERMITS

The Co-contractor shall execute the closure of the work area, when and as appropriate, in accordance with the local regulations in force and the terms hereof.

6. INSURANCE

The Co-contractor must obtain all insurances related to labor risks, third party and property damage prior to the commencement of the work.

7. CLEANING

The Co-contractor must maintain daily cleanliness at the site, including the final disposal of waste and debris generated by the execution of the works.

7. GUARANTEE

The Co-contractor must guarantee the works for TWELVE (12) months as from the day after the Final Acceptance.

8. DESCRIPTION OF WORK

This item includes the following tasks:

- a. Removal of existing AO SMITH PROMAX model FCG 75 300 75-gallon gas-fired thermos tank.
- b. Provision and installation of new gas water heater type CCY 75G MBH WHTR ALUM or higher.
- c. Provision and installation of an expansion tank compatible with the new water heater and in accordance with local regulations in force.
- d. Replacement of currently rusted and leaking mixing valve with a new valve of the same material and dimensions. The supplies and accessories necessary to carry out the work shall be included.
- e. Tests and trials necessary to corroborate proper installation.

The installation shall include, if necessary, all the necessary accessories and supplies for the startup of the filtering system, including water supply pipes.
