1) The toilet located on the ground floor of the Embassy building: Water gushes out when it is flushed, causing its contents to spill onto the floor.

Diagnosis and work to be carried out by the company to adapt and repair the toilet: The pipe does not have ventilation and therefore it would be necessary to create a ventilation for it in the basement. The 15-foot pipe need to be cleaned.

2) The toilet located in the waiting room of the Consular Section: It presents problems when flushing it, causing its contents to spill on the wooden floor and carpet. On the other hand, it is constantly clogged.
